DMV TO LAUNCH PILOT FOR ELECTRONIC VEHICLE REGISTRATION SERVICE

DMV is preparing a pilot project for a new vehicle registration service through some new automobile dealers.

The Electronic Vehicle Registration (EVR) system will allow participating dealers to issue plates and stickers to customers at the time of the vehicle's sale. During a 3-6 month pilot project, up to 10 new car dealers will enter vehicle title and registration data into a computer system and send paper documents to DMV via an integration company called Computerized Vehicle Registration (CVR).

The pilot will test the EVR system and procedures, which cover such transactions as new titles and title transfers, as well as registration, including new plates and plate transfers. The software also will allow dealers to perform some vehicle record inquiries.

CVR will supply the title and registration software for EVR. The company also will provide on-site installation and training during the pilot project, and it will perform ongoing technical support for the software.

CVR, which has been in business since 1992 and is serving vehicle dealers in 11 states, is working directly with Oregon dealers who are participating in the pilot. The pilot dealers will include Mercedes-Benz of Portland, Herzog-Meier Volvo VW, Capitol Chevrolet, Town & Country Chevrolet, John & Phil's Toyota, Crater Lake Motors, Armstrong Buick VW and Ron Tonkin Chevrolet.

DMV is committed to meeting the service needs of Oregon's vehicle dealers through its Dealer Processing Centers and other DMV field offices that handle dealer work, as well as EVR. DMV will decide how to move forward after the pilot is evaluated.

VIN INSPECTIONS

You can only perform VIN inspections on vehicles that are in your dealer stock. DMV or State Police must perform the VIN inspection on vehicles from outside the United States, vehicles declared totaled or reconstructed by an insurance company or vehicles on consignment. See Chapter E of the Title and Registration Handbook, pages 29-31 for more information.

A SURVIVORSHIP PRIMER

What does survivorship mean when you see it on the title application or title? The term survivorship means the existence of joint ownership of personal property. Who can request survivorship? Survivorship can be requested by two or more **individuals**.

When survivorship is noted on the title application, it is then shown on the title and DMV vehicle record. A title showing survivorship between owners may be transferred to remove a deceased owner simply with proof that the one owner has died. If there is no survivorship between owners, DMV will require either copies of Letters of Testementary showing appointment of a personal representative if the estate is probated; or Inheritance Affidavits signed by **all** heirs to the estate if the estate is not being probated, in order to transfer title (See Chapter H of the Title and Registration Handbook for more details).

Remember, survivorship is **not** automatic for two or more individuals on a title. The individuals **must** request survivorship by noting it on the application for title. If neither box is checked, no survivorship will be shown on the title or the vehicle record. DMV field office employees cannot determine survivorship between individuals, and therefore are not allowed to mark the survivorship box on the application.

Dealers, remind your staff to check with your customers when buying a vehicle on whether they want survivorship shown on the title. Based on your customers response, be sure to mark the "yes" or "no" boxes for survivorship on line 12 of the application for title for motorized vehicles, Form 226, revision date 09/01 (or line 11 of the application for title on non-motorized vehicles, revision date 09/01). It is not only good customer service to ask customers about survivorship, it is also your responsibility as an agent of DMV to properly complete the application for title. It could mean the difference between an easy title transfer or a complicated title transfer for you and/or your customer down the road.

REVISED UNLICENSED DEALER WARNING FORM

DMV Business Regulation has re-designed the Vehicle Dealer Warning Form used by dealer investigators. This form shall be placed on vehicles being displayed for sale in unlicensed publicly accessible locations. It explains, to the suspected unlicensed dealers, that the vehicle displayed for sale may be in violation of state law and may lead to imposition of a civil penalty.

The revised form contains more information concerning Oregon law and the consequences of acting as a vehicle dealer without a vehicle dealer certificate. In this respect, it can serve a dual purpose in advising both the seller and the unsuspecting consumer.

The form has been redesigned to better withstand the weather. They will adhere to the windshield, yet be easy to remove without leaving a glue residue. A very noticeable and easy to recognize goldenrod color was chosen for the DMV form.

Dealer investigators will begin using the Vehicle Dealer Warning Form on November 1, 2002.
